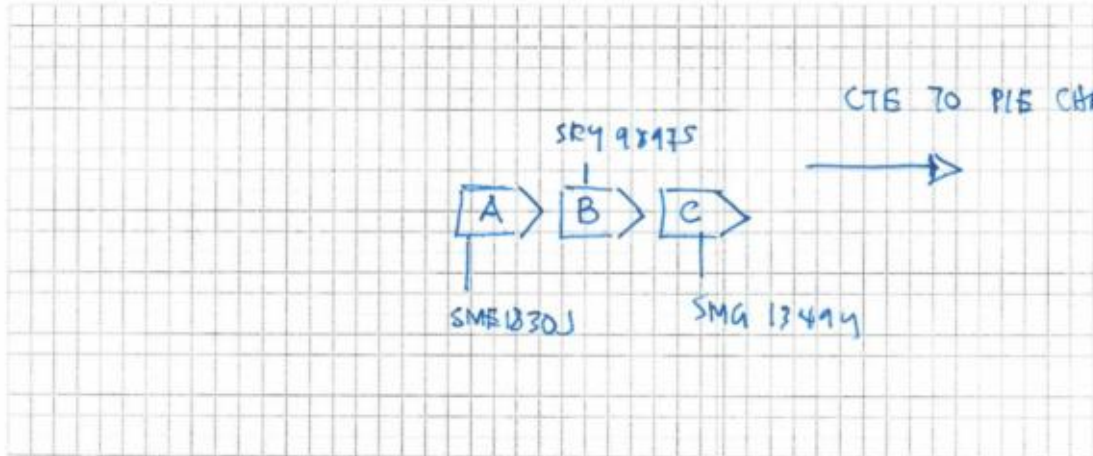

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving along the sliproad from CTE into PIE Change. The car in front SFY 98975 stopped suddenly and I stepped on the emergency brake but the car still knocked on to the rear bumper of SFY 98975. SFY 98975 still knocked onto SMG 1349Y. I wanted to check on the status of all the other car's passengers and drivers. No one was injured. The bumper of SFY 98975 was dented and the front logo of SFY 98975 also fell out. There was no other visible damage to the other parts of SFY 98975. SMG 1349Y has its rear panelish fell off and some scratches on its rear bumper. There was no other visible damage. For my car - SME1830J, the Fog Lights were damaged. SFY 98975 also has a dent on its rear boot. My right bumper also dislodged.
