Dear Ms Saliha, I have contacted the 3rd party workshop. I have an appointment with the owner tomorrow, 3 October 2019 to conduct the height measurement on his vehicle.

As for the insured, I have inspected his vehicle for damages and conducted the necessary height measurement. He is very adamant that all the damages I observed on his vehicle are old damages and not a result of this accident at all. He was not pleasant to deal with as he kept hovering around me as I did my inspection and scrutinized my work. He even asked me whose side I was on because I kept pin- pointing all the damages on his vehicle. He refused to send me the photos taken at the accident scene and told me to obtain said photos from AIG although he still had them in his phone as he showed them to me.

However he does not deny contact. He admitted that he hit the 3rd party's car while reversing. He is disputing quantum as he claims there's no damage on the 3rd party's car. Once I have obtained the height measurement I will proceed with my report and forward it to you after my senior has reviewed it. To facilitate this, I humbly request that you email me the photos the insured took at the accident scene as I need these for my report.

I did find damages on the insured's vehicle but I cannot ascertain if these are a result of the accident until I am able to compare the heights of these damages to the damages on the 3rd party's car.
