#### **Circumstances of Accident**

Upon very very slow reversing SLT230E lightly hit the front license plate of SJV 5105P. There was no damaged nor paint transfer from SLT230E to SJV 5105P. Upon alighting and inspection a slight dent on driver side of the license plate corner. As it was a straight rear to head it was not possible for the =driver side license plate to be slightly dented. Driver Yap claimed that he need to file accident claim to Audi. However we noted the slight dent was very old and did not have any sign of my car paint at all and since it was straight it was also not possible to dented at the corners. Dr SJV5105P claimed that vehicle was just bought but noticed it was a 2017 model anda Premium Auto pre-owned car. While the driver insisted to file report though there was no damage to any other part of the body except the old dent mark on the license plate. I wish to report that this is potentially a scam claim for actually damaged not resultant of the light hit and not possible for the dent at only a corner of the vehicle. Dear insurer filing this report to alert U of the potential scam which could be hefty.


