I WAS DRIVING ALONG UPP EAST COAST RD TWDS BEDOK RD AT THE RIGHT LANE OF A2-LANES DUAL CARRIAGE WAY. 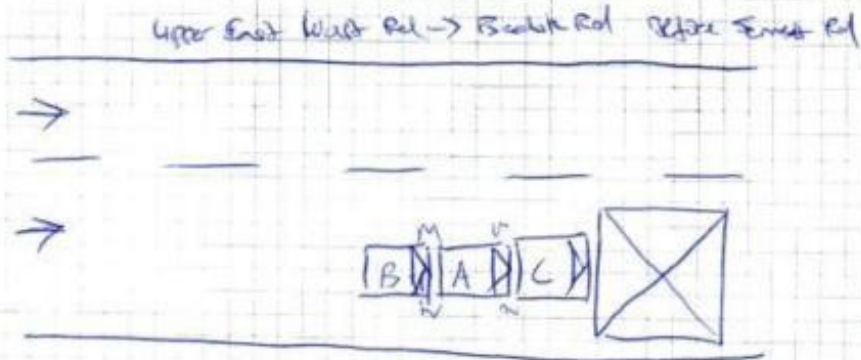

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

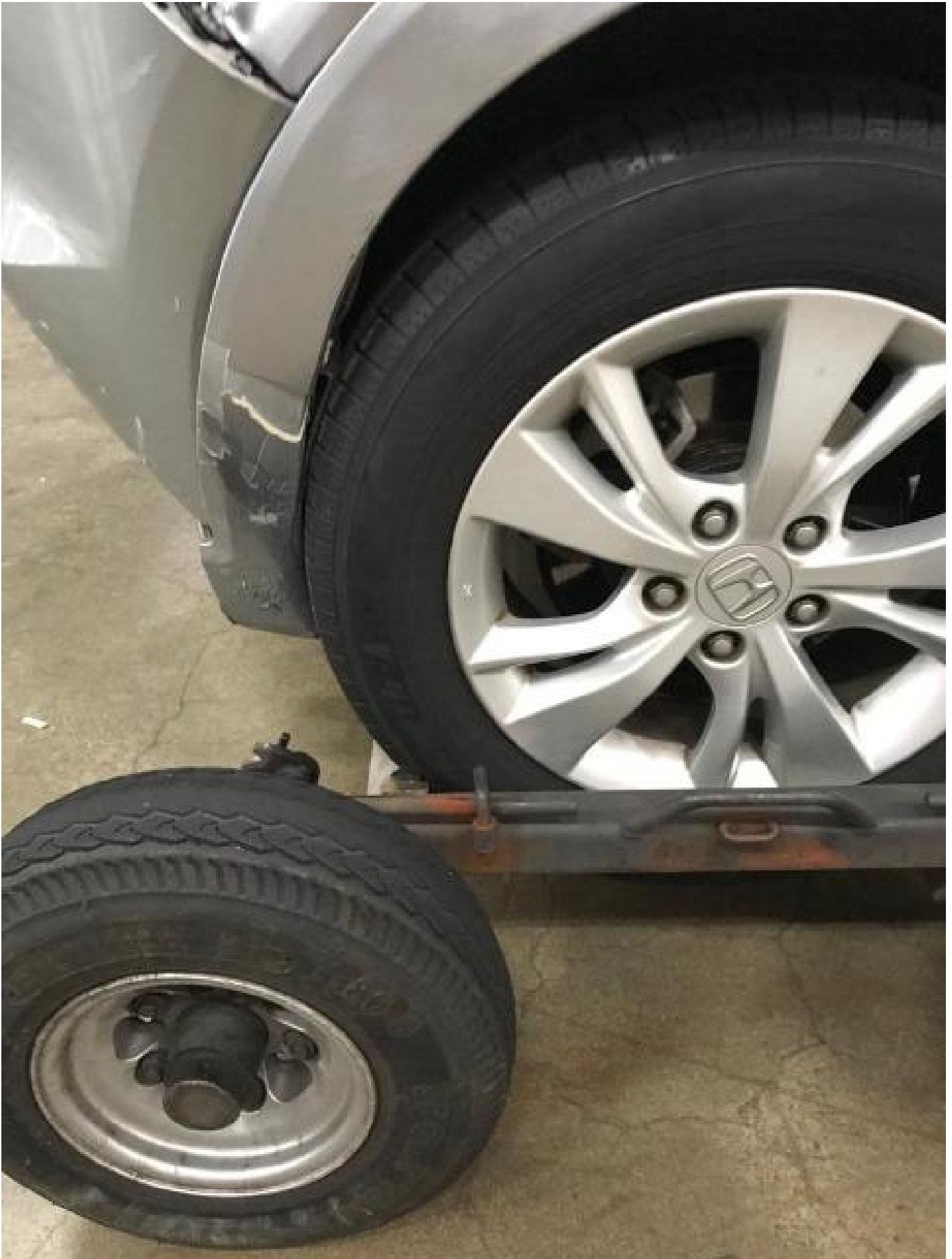

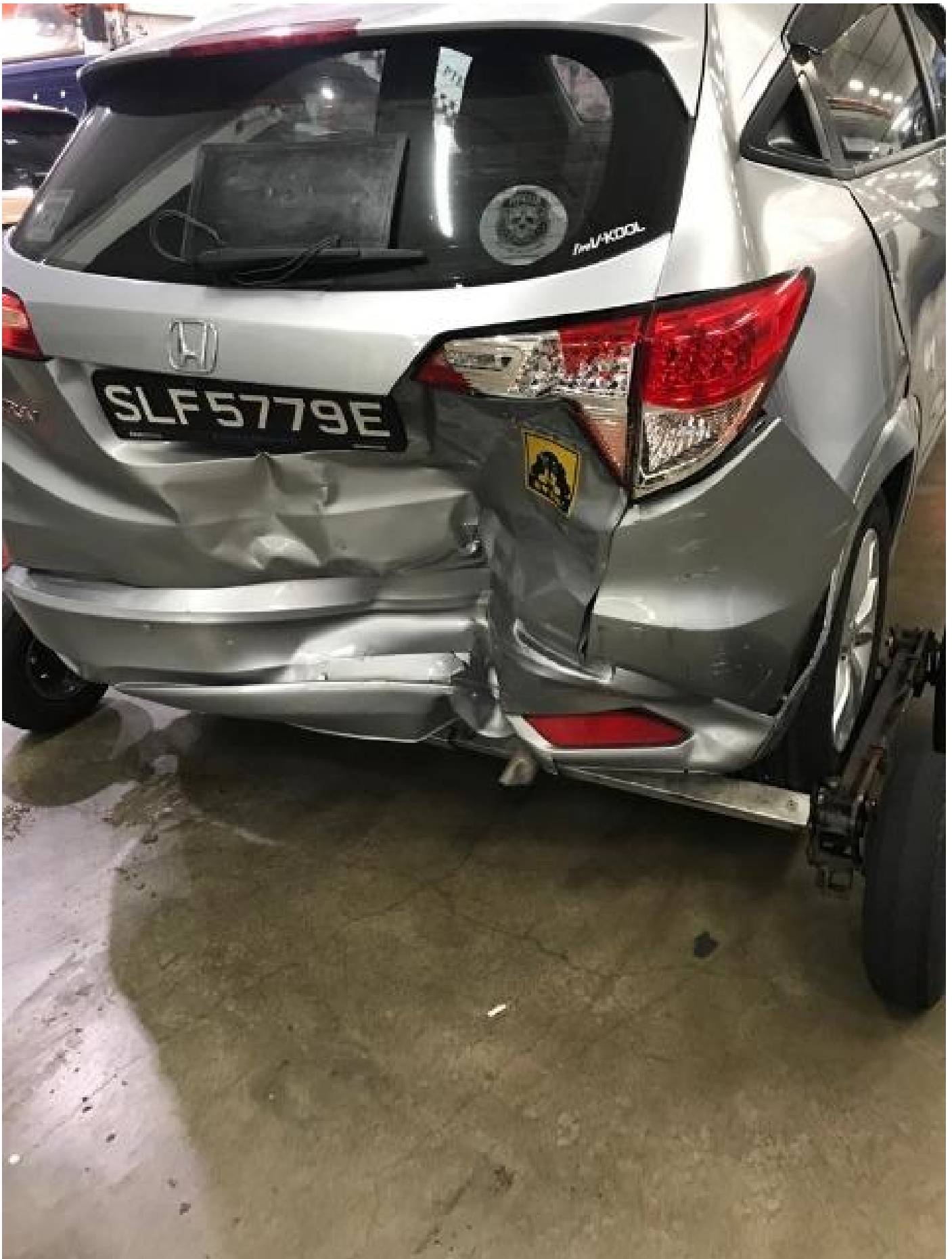
