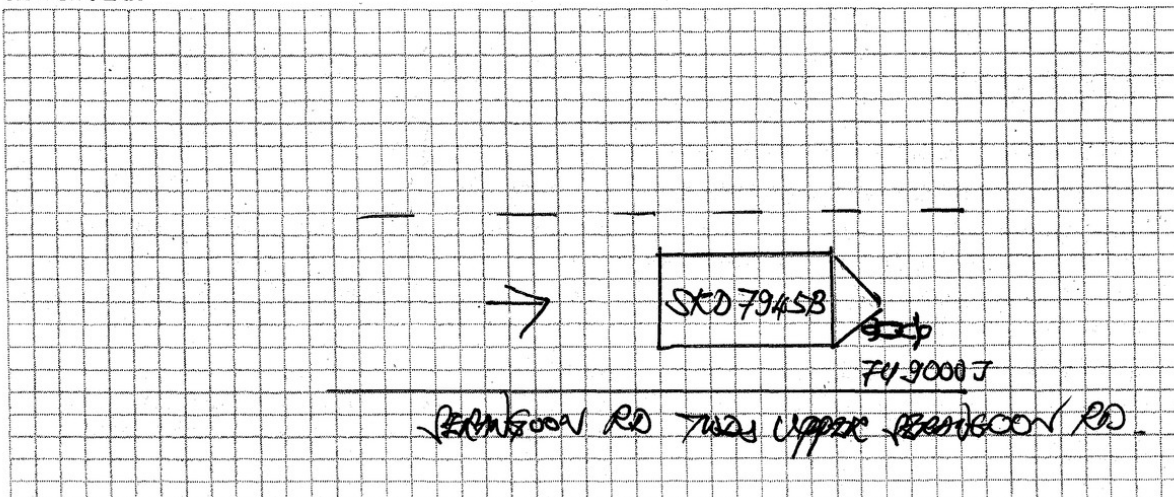

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On the date 14 Sept 2019 at approximately 1245am, driving along Seringgon Road towards Upper Serirggon Road. 2 motorbikes was sheering towards the right to make a right turn into a car park. He applied his brake and I didnt have enough time to apply my brake on time and knock on his back of his motorbike.
