SKETCH PLAN





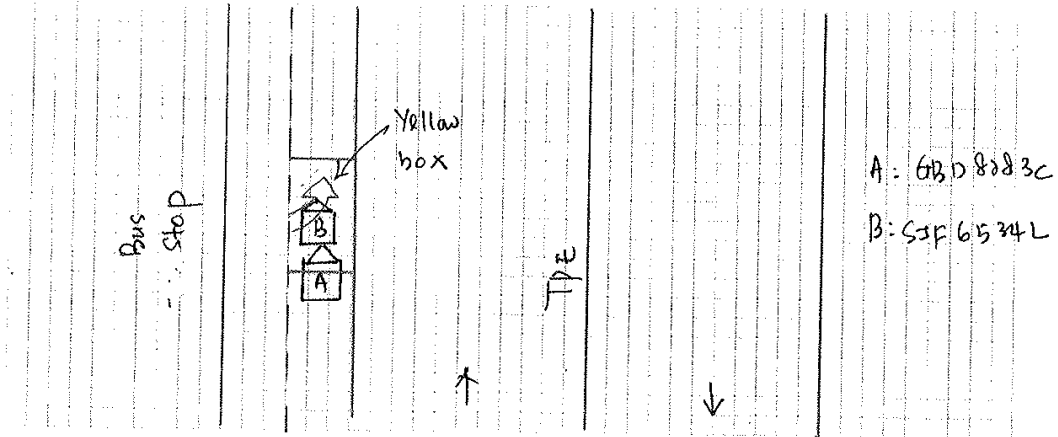
