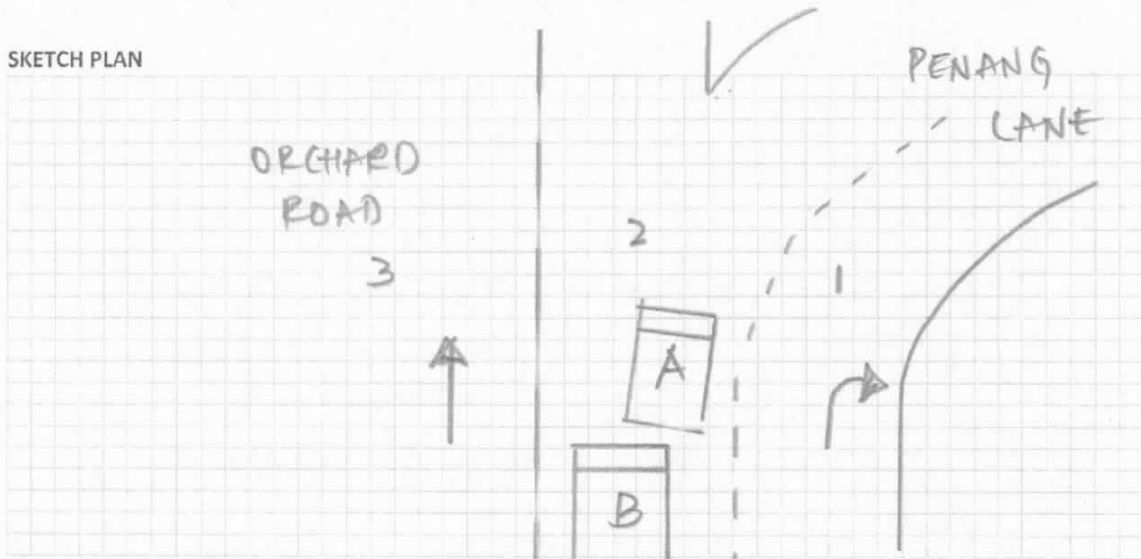

Describe Circumstance of the Accident.

ON 23/09/2019 @ 0045HRS, I WAS DRIVING MY TAXI (SHB 8535 R) – TRAVELLING ALONG ORCHARD ROAD IN LANE 2 (ARROW ON ROAD SURFACE SHOWS STRAIGHT AHEAD & RIGHT TURN).

WHILE I WAS SLOWING DOWN MY TAXI TO TURN RIGHT INTO PENANG LANE WITH MY RIGHT INDICATOR – SUDDENLY I FELT AN IMPACT FROM THE REAR.

WHEN INSPECTED, I DISCOVERED THAT VEHICLE B (PC 6023 P – PASSENGER VAN) WHICH WAS BEHIND ME, HAD COLLIDED ONTO THE REAR OF MY TAXI.

DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE REAR & I WAS NOT AWARE OF DAMAGES TO VEHICLE B.

AS A RESULT, I FELT PAIN ON MY HANDS AND WILL SEEK FOR MEDICAL TREATMENT IF NECESSARY. NO AMBULANCE AT SCENE.

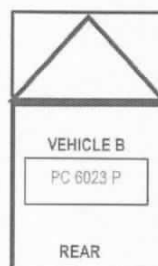
