

SKETCH PLAN




DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

As I was approaching the carpark exit of Tradehub 21, I had to make a left turn.


As I was turning left, my vehicle was hit on the right by vehicle B, which was from the extreme right lane.
