

I have a front in-car camera installed.

At that point of time, no one was injured. However, I subsequently went to see the doctor as I felt back stiffness and was given 3 days MC (MC no: 000020826) from 24/09/2019 to 25/09/2019.

Due to the accident, my car had its rear bumper dropped and cracked.
