

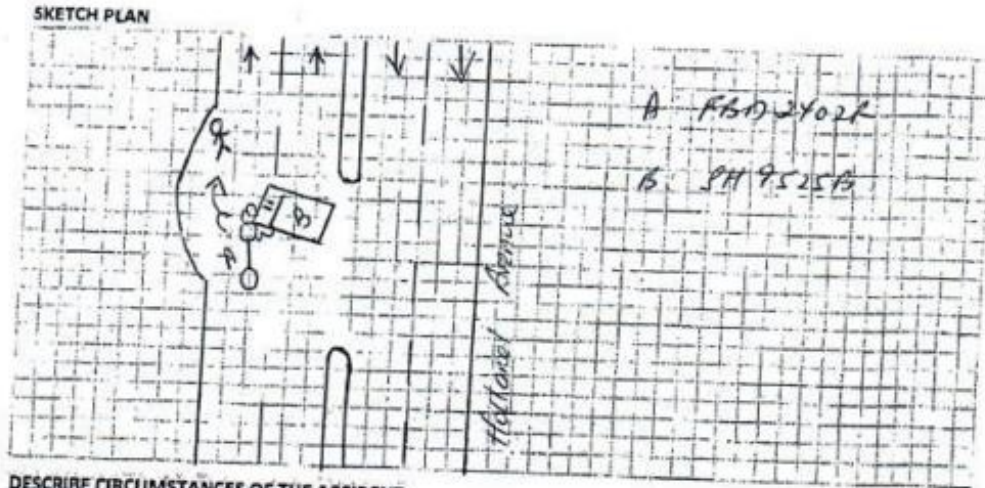

### Brief Details.

On 19/09/2019 at about 2000hrs, I was riding my motorbike V1) FBD2402R along Holland Avenue heading towards the direction of Holland Road. As I was riding on the right lane (two lane road) I noticed that there was a taxi V2) SH9525B at the opening in between the center divider (V2 is coming from the opposite direction from Holland Road towards Holland Avenue) trying to negotiate a U-turn. Based on my observation, the driver of V2 seem to be indecisive if he wanted to negotiate the U-turn. I had sounded my horn at V2 to alert the driver that I was approaching however the driver of V2 still continued with the U-turn. When I saw that V2 was not stopping, I had moved to the left lane to avoid any collision however to no avail. V2 front portion eventually collided into the front right portion of V1. The impact caused me to be thrown off my bike and subsequently I landed on the road about 2-3 meters after the point of collision.

After the accident, the driver of V2 (Male, Chinese about 40 years old) together with two other road users came to my aid. Subsequently the ambulance and the Traffic police (E/20190919/0102- In-Charge case TP IO Hidayu Tel:65476423) arrived at scene. I was subsequently conveyed to National University Hospital for further medical attention in a conscious state. I was treated for abrasions on my left arm, shoulder, leg, feet and chest. I was also given 04 days of medical leave dated from 20/09/2019 to 23/09/2019.

I wish to state that I did not manage to exchange any particulars with the driver of V2. The two road user (motorcyclist) who had assisted me had provided me with their contact number and informed me that they are willing to be the witness to the accident.
