Dear Julie

Have inspected the insured vehicle earlier today.

Interior compartment observed to be completely burnt to char. The engine compartment sustained less severe fire damage. No modification found fitted on the insured vehicle.

Photos posted in STOMP showed fire engulfing the interior compartment rather than its engine compartment. Basing on the burnt pattern, it would appear to me that the fire had originated at the left centre of the insured vehicle. When I checked the underside at the left centre area, I found some burnt string like material stuck to the underside. The same area at the right side of the insured vehicle did not have similar type of material.

I am hence of the opinion that the fire to the insured vehicle was likely due to external factor where the insured vehicle may have gone over some combustible type of object, which got heated up when came into contact with hot surface part of the insured vehicle and/or had created frictional heat through resistance against the road surface when the insured vehicle was moving. This led to the eventual ignition of fire.

MV of insured vehicle will be reverted to you by my colleagues. Meanwhile for your further instruction on whether a technical report is required.
