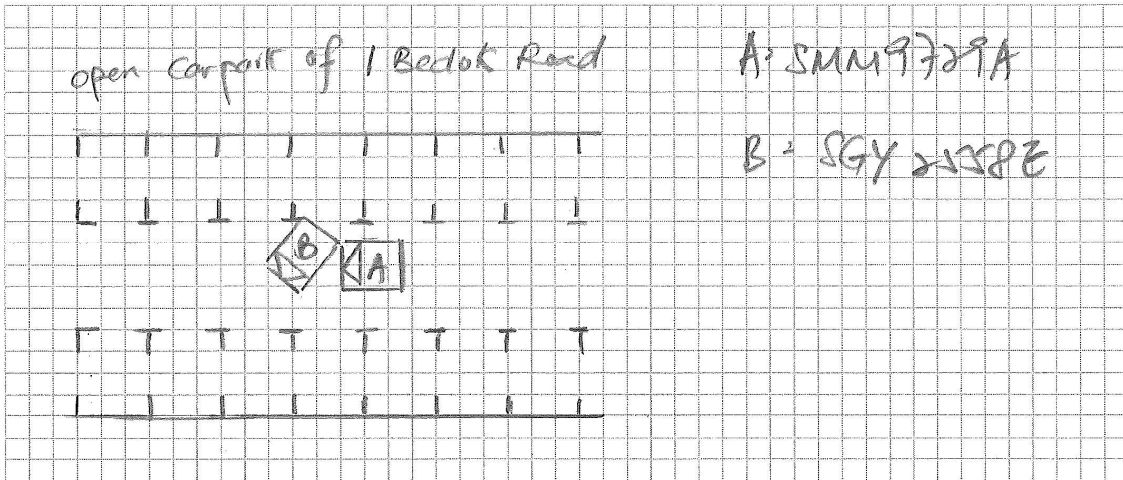

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I had been parked in the car park at the place of the incident. The other vehicle involved entered the car park as I was leaving and I moved off behind the other vehicle. At around 1759 hrs the driver of the vehicle in front of me came to a stop without any hazard light indicating he might reverse. I stopped safely behind him and checked my rear to see if it was clear to reverse. Without warning the driver of the vehicle in front of me started reversing, as if he was entering a parking lot, and before I could sound my horn, the vehicle collided into the front of my vehicle. We both exited the vehicle to access the damage and he then told me that he would make a round to stop his car behind where he wouldn't obstruct the way. I then took images of the damage, exchanged contact details and we both agreed to submit to claim through insurance.
