a) Case IAFP-IB-20191003 - Mechanical Inspection of Motor Van, GZ557R (TP/IP/44533/2019)

On 17 July 2019 at about 04.50 pm, Police incident was created regarding an accident along Marymount Rd by Marymount Lane. The motor van, GZ557R, was travelling on the rightmost lane of 5-lanes along Marymount Rd towards Thomson Rd.
