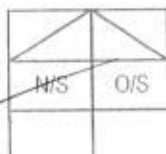

We refer to the above matter and to your e-mail dated 12 June 2019.

We wish to highlight the following:

- i. Our letter of demand dated 29 August 2018 (received by FCI on 30 August 2018) informed you that our client had not carried out the repairs. Further, we invited FCI to send their surveyor down to conduct the PRI, if any; and
- ii. On 8 October 2019, we received your e-mail acknowledging our LOD. However, you did not inform us if you wanted to conduct the PRI nor did you inform us if you wish to appoint surveyors to conduct the PRI.

We also wish to highlight that the NIMA Protocol serves as a guide and the breach as alleged by you, which is not admitted, will affect the issue of costs, if at all.

Your offer dated 12 June 2019 was not based on total loss but on OMV minus COE rebate. This OMV does not include all the other incidental costs that was incurred by our clients. We have previously forwarded to your our client's surveyor's report (along with coloured photographs of our client's motorcycle) dated 7 July 2017. In the surveyor report, the surveyor has checked and quantified the pre-accident average market value of our client's motorcycle at \$45,662.50. As such, if you wish to dispute the claim for total loss of our client's motorcycle then we hereby invite you conduct the PRI of our client's motorcycle which is still untouched but relocated to:

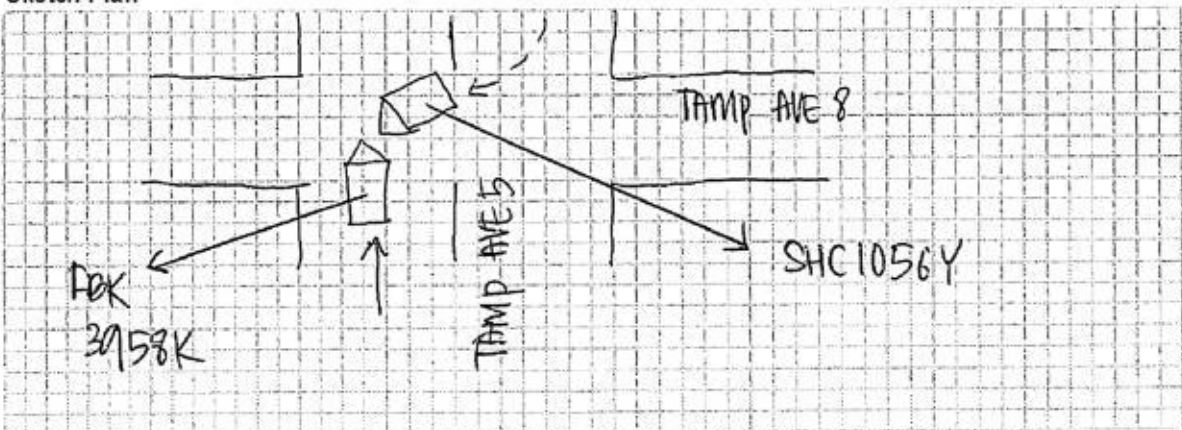

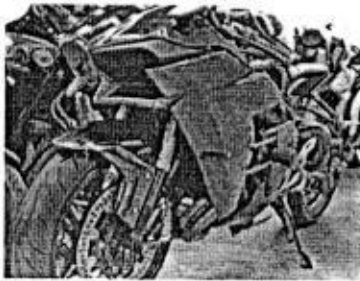
