While my bus SMB1475S was filtering to the left lane at Newton Circus, after BS: 40031, the left centre body had grazed against the right front body of a taxi (SH8315Y). No injury reported. Third party driver refused to move his vehicle and request for police. Police and field team activated. 6 pax were transferred. Field team arrived and managed to ask the taxi driver to move his vehicle. At 0958h, after exchanged particulars, bus was driven to BS: 40041. Police was cancelled. I was unable to continue my trip and request to terminate my duty. Bus will be arranged to drive by another BC. Bus left centre body scratched. Taxi right front body scratched. That's all.
