SKETCH PLAN

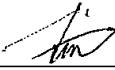

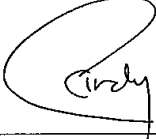

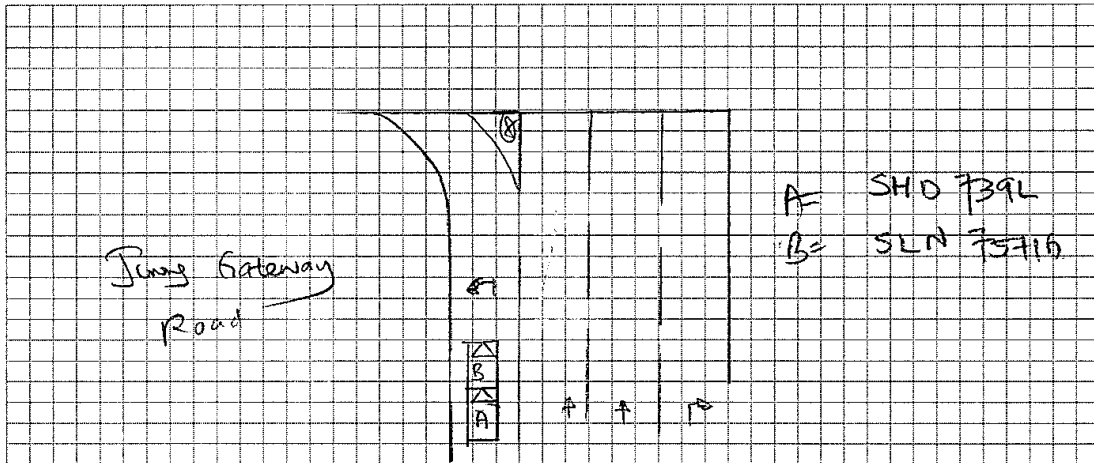
