### DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

The accident occurred at the CTE Exit lanes when I was travelling slowly and following the front car in front to exit expressway on the left and provided left turn signal early and in advance. After the front car taxi turned into exit lane, I waited for the next car on my left to also move ahead before following the car to filter into exit lane. After I am already in the exit lane, a taxi behind me cut into my back and his right front bumper hit my left back bumper wheel area. The taxi failed to keep a safe distance and give right of way and hazardous driving without braking rear-ended my car.

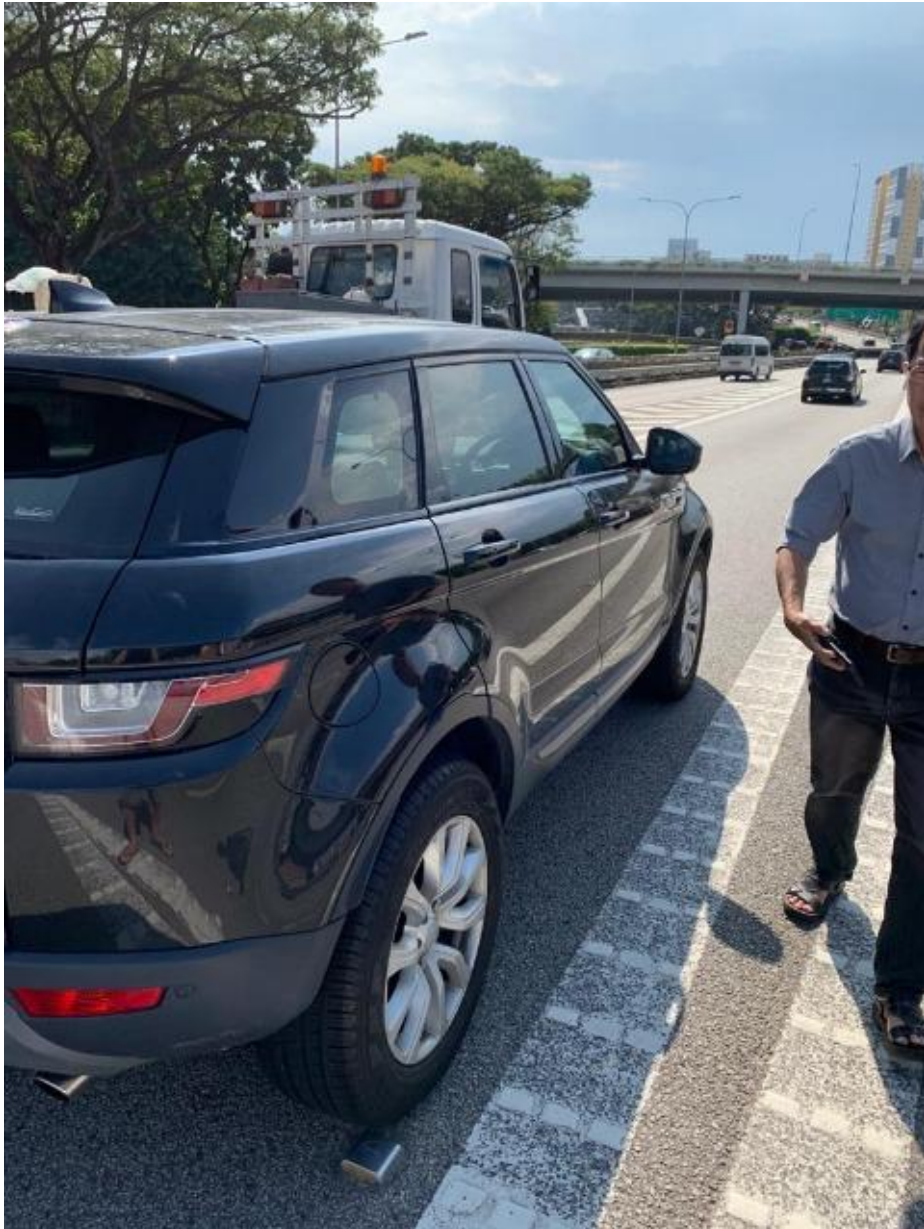
