### Brief Details.

On 1st October 2019 at around 8.05am, my wife was driving my car along corporation road, sending my two kids to school as usual. Traffic was quite heavy and it was red light, so all car stopped. There was a gap on the right lane so my wife signaled to the right and slowly drove into the right lane. She couldn't completely move to the right lane due to the tight gap with the car in front. When the traffic light turned green, there's a truck that was in the right lane moved forward from behind and collided onto my vehicle (which was in stationary position). Both vehicles ended in stationary position after the collision. Seeing a big truck hitting our car, and the turbulence, my kids were screaming and crying in the car, and my wife was also in shock condition. In that traumatic situation, my wife panicked and drove away from the scene as a natural reaction to avoid the source of stress. She didn't get any picture nor any detail of the truck that hit her.
