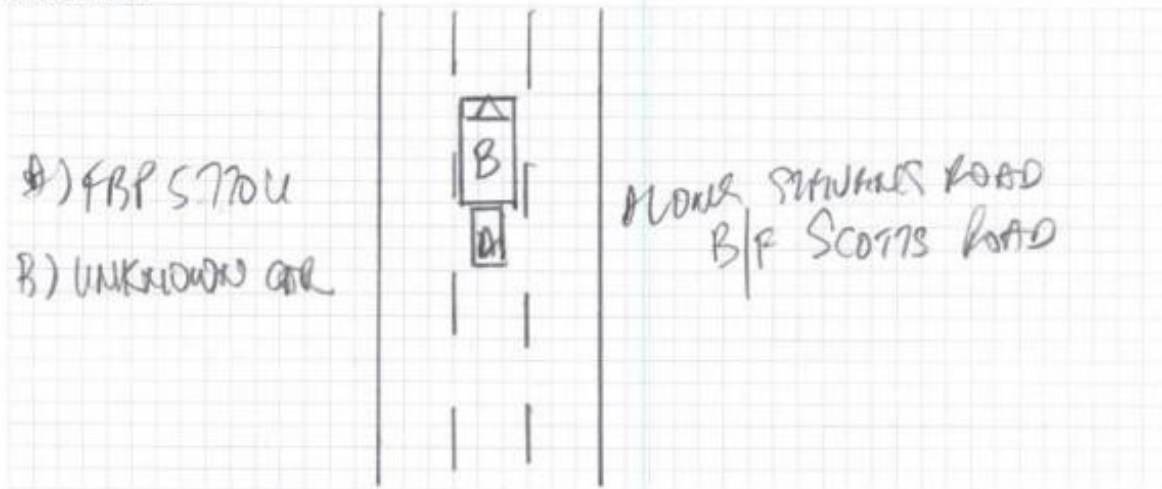

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

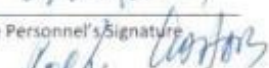
on 09/10/2019 at about 16:30hrs I was travelling
