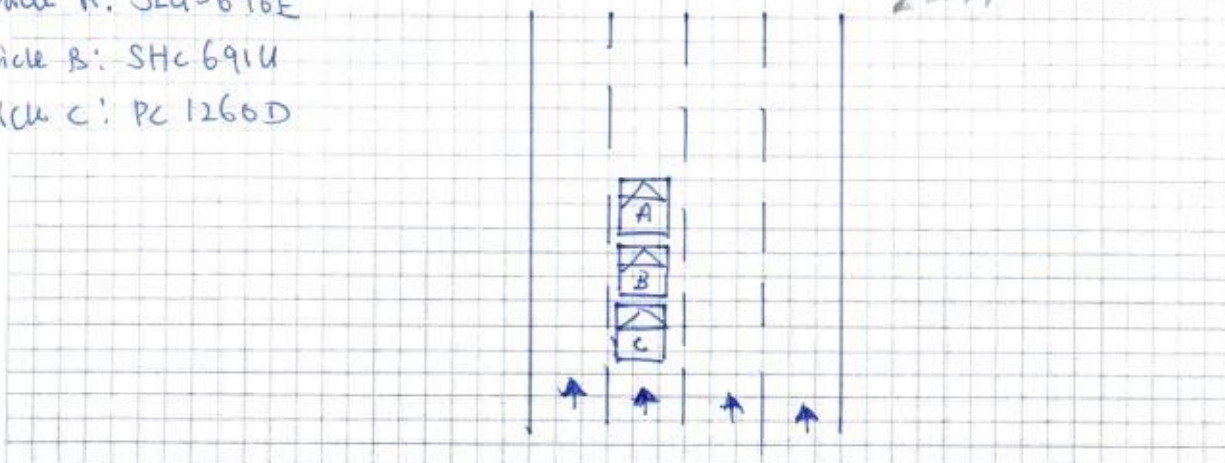

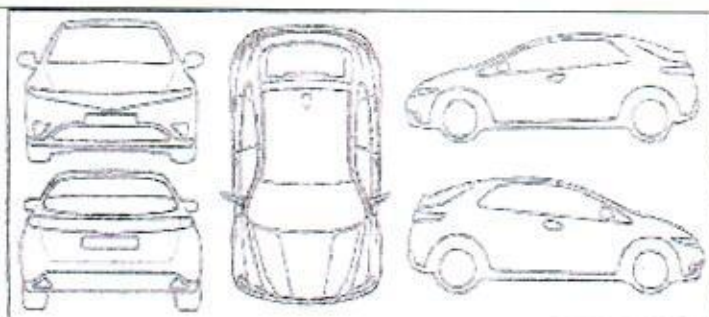

- > tire rotation @ every 10,000KM or mileage determined by the owner.
- > tires change @ every 50,000KM or mileage otherwise determined by the owner

(ii) The owner reserves all rights to demand any resultant costs and/or damages from the hirer for non-conformance of clause 5(b).

(iii) In the event that the hirer sends the vehicle to the owner's workshop(s) without adhering to clause 5(b), the hirer will still be liable to pay rental for the time spent under such circumstances.


