Brief Details.

On the 5/10/2019 at about 1535hrs, I was diving my car (V6: SKD319E) along PIE about 16 km exit towards Changi Airport. I was driving along the first lane (right most lane) at about 60km/hr and there is heavy traffic. The cars in front of me was travelling at about the same speed as me. Afterwhich, Traffic Police came to attend to us and my in-car camera SD card was given to him for further investigation. NP323 was issued to me.

I wish to state that there are damages on the front of my car.
