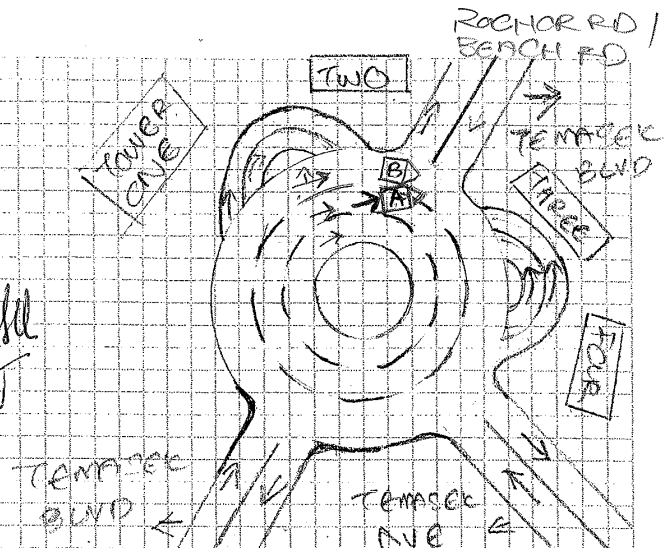


SKETCH PLAN
