CONTINUATION OF REPORT

Brief Details.

On the 14/10/2019 at 0845hrs I was driving along KPE going towards City before the tunnel, just before Paya Lebar exit. I was sending my friend back to Johor Bahru, we were travelling on the extreme right most lane, the first lane. Just before entering the tunnel, two cars before my car had a collision so the cars had come to a stop. I had just come to a stop behind the red car (SJZ7536U), 3 Seconds later I felt a huge impact against the rear of my vehicle. A white Mercedes Benz taxi (SHD8865C) had collided into the rear of my car, causing me to knock onto the car in front of mine, the red car. All parties involved then exited their respective vehicles to make a check, take photos as well as exchange particulars. Shortly later, LTA arrived followed by the paramedics. The paramedics then made a check on my friend who was travelling with me, he had sustained a cut to his left eyebrow and was bleeding. The other drivers and their passengers were alright, my friend was then conveyed by the paramedics to the nearby hospital for further checks. My vehicle being the center car was badly damaged and was towed by EMAs, afterwards I had one of my friends come to pick me and so I went to a clinic to get a check as I felt discomfort and pain to my back and neck after the accident and got a 3 days Medical Leave. I wish to state that during the time of the accident, I had no in car camera inside my vehicle but the Taxi had one. I was advised to lodge a traffic accident report as soon as possible as instructed by the IO.
