Brief Details.

I am a relief taxi driver for Transcab. On 11/10/2019 at about 8.32pm, I was driving my taxi bearing registration number SHC5628X, Renault red colour. I was travelling on the extreme right lane along PIE towards Tuas. Upon reaching Eunos flyover, suddenly the car in front of me jammed brake. Immediately I applied my brake and managed to stop just in time to avoid any collision. Unfortunately, once my taxi came to a stop, suddenly I could feel that my taxi was being knocked from behind. I came out to make a check and realised that it was a chain collision involving three vehicles. One black Honda Vezel, bearing registration number SJD4959T had knocked onto the rear of my taxi and another vehicle, one silver KIA Cerato Forte bearing registration number SMA4431D had knocked onto the rear of the said Honda Vezel.

I wish to state that I had one female passenger, name given verbally as Melissa c/no 94308049 sitting at the left rear passenger seat. She complaint of pain at the back of her body. When I offered her to call for ambulance, she refused citing that she was in a hurry. I explained to her that due to the procedure, I was unable to continue driving my taxi and she acknowledged. I wish to state that I did exchange particulars with the two said drivers : - Allyson Chin Kit Leng S9536790I, c/no 97559010 (SJD4959T) and Lee Jia Jun S9138460D, c/no 93807475 (SMA4431D). Damage to my taxi as follows; spoilt rear boot and rear bumper badly dented. My taxi was eventually being towed away.

I further wish to state that I suffered whiplash as I felt pain on my neck area. I went to Finest Health Medical Centre in Toa Payoh on 12/10/2019 to seek medical attention. I was then given three days of Medical Leave for a period from 12/10/2019 to 14/10/2019. My taxi does not have any In-Car camera installed.
