Brief details.

On 10/09/2019 at about 0938hrs, I was driving along Tiong Bahru Road entering Zion Road in my vehicle bearing registration plate number, SKF8128B. I had stopped at a red light on a one-way road that had two lanes, at the intersection of Tiong Bahru Road and Zion Road and I was on the right lane. After I stopped I had put my vehicle in neutral and kept my foot on the brake pedal. As the light turned green, I wanted to put my vehicle into drive but accidentally changed it to reverse, as my vehicle is using a steering wheel stock as the gear lever. My vehicle then moved backwards and collided rear first into the head of another vehicle, bearing registration plate number, SMA6532H. I then got out of my vehicle and

spoke to the driver of the other vehicle, Mr Chia Der Yunn (Hp: 83387805). We discovered that there was a paint scratch on the "Toyota" badge of his vehicle and there were no other damages to his or my vehicle. He also told me that his vehicle does not belong to him and that he would try to get his vehicle fixed at his own workshop. I had one passenger in my vehicle at the time. I did not notice if anyone was inside Mr Chia's vehicle my passenger, my wife, as well as Mr Chia and I were not injured from the accident. My vehicle's dashcam was operating at the time of the accident and I have footage of the accident as well as photographs of the damages on my vehicle.

I told the Mr Chia that I would pay willing to repair the damage on his vehicle and he agreed at the time. I had later spoke to him over the phone and asked him to send me the photos of his vehicle's damage and the cost to repair and he said that he would do so and Mr Chia also told me that he was driving for Grab and that Grab would contact me regarding the accident. On 10/09/2019 at about 1005hrs I messaged him Mr Chia to remind him to send me the photographs of the damages on his vehicle but he did not reply. I then messaged Mr Chia the details of my workshop for him to bring his vehicle. The workshop is Falcon-Air Auto Services Pte Ltd located at 176 Sin Ming Drive #01-06/07/13/#05-17 Sin Ming Autocare Singapore 575721. I also sent him the name and contact number of an employee at my workshop for him to contact, Mr Joshua (Hp: 96588125). However, he did not respond to my messages.

On 10/09/2019 at 1852hrs, I called Grab and they informed that they have no record of our accident. I then gave Grab the particulars of Mr Chia and they informed that his vehicle is from a rental company and that they could not disclose which rental company. Grab then informed me that they would contact Mr Chia to tell him to contact me. Mr Chia then called me and informed me that his rental company would contact me regarding the issue. The rental company then called me from Hp. 86681223, and they told me

that they could not settle the matter with me as there was a passenger in the vehicle at the time of the accident. I then asked the rental company how I could settle the issue and they informed that they would be making a large claim from my insurance company for severe damages sustained to Mr Chia's vehicle, which could cost up to SGD\$2000/-. I then told the rental company that if he wanted to make a claim with my insurance company, AIG, that they could do so.

I then decided to lodge a police report for record purpose as I fear the rental company would make false claims regarding the accident and about the extent of the damages on Mr Chia's vehicle.
