May I seek your assistance to perform a detailed mechanical inspection of the following **3 vehicles** on an urgent basis as the vehicles below are required to be returned to the owners ASAP:

a) **Case IAFP-IB-20191020 - Mechanical Inspection of Motor Taxi, SHD5936B (TP/IP/32821/2019)**

On 24 May 2019 sometime before 3.33 a.m., the accused was driving his motor taxi on lane 1 of 4-lanes along PIE towards Airport near to Paya Lebar Road Exit when he ran over the Deceased, which was lying on lane 1 of 4 lanes road after the Deceased had self-skidded. Deceased was pronounced dead on the spot by Paramedics due to multiple injuries.

On 24 September 2019 (Tuesday) at about 4.10 p.m., the Involved Party was driving his motor trailer, PKS7337 along Ayer Rajah Expressway towards Tuas on the extreme left lane and made an abrupt lane change to the right to avoid colliding onto a motor truck who applied sudden braking. In a process of making a lane change to the right, the trailer had collided onto a motorcycle who was travelling on his right and the motor truck ahead of him.
