While travelling straight on the right lane along Teck Whye Avenue crossing the junction towards Choa Chu Kang Drive, a pte car (SJL5388S) that was from the opposite direction attempted to turn right into Choa Chu Kang Ave 1 when traffic light was green in my favor and collided into the right centre portion of my bus. 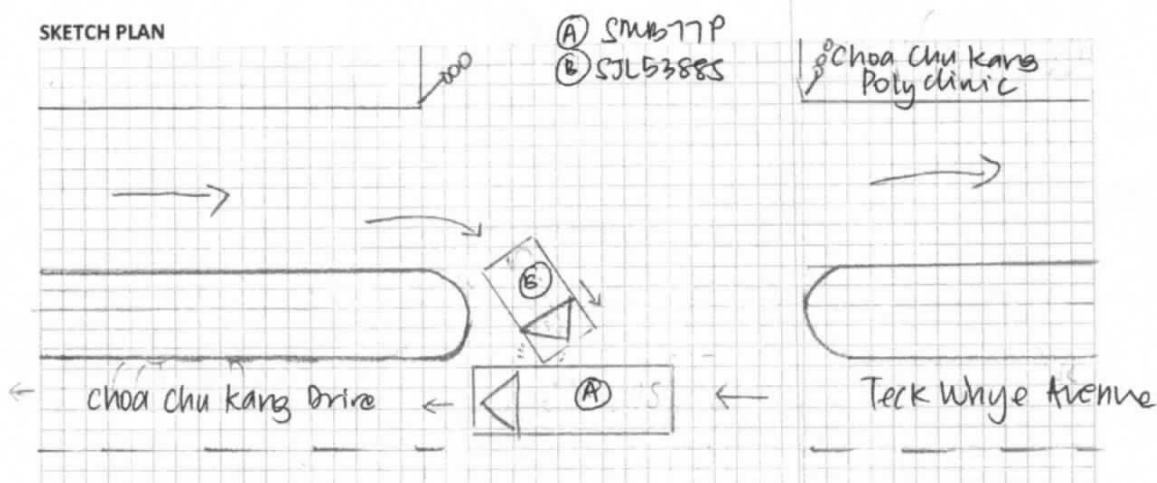
