Brief Details.

On 19/10/2019 at 1415hrs, I was driving along PIE towards Changi Airport before Toa Payoh Exit at lane one. As the traffic was heavy, I noticed that the vehicle in-front bearing the registration number SGP2273Z came to a stop. I then slowed down my vehicle and eventually came to a stop. I look at my rear mirror and the vehicle behind me bearing the registration number SJU8475G had also come to a stop. About 5 seconds later, I heard two to three loud bang sound and I feel a huge impact on my rear of my vehicle and my vehicle moved forward and knock on to the vehicle in-front of me. I then went down of the vehicle immediately and realized that the vehicle behind me bearing the registration number SJU8475G had hit on to my rear of my vehicle and it was a chain collision. The plate number of the other involved vehicles was SJS1771H and JKM8279.

Subsequently police and ambulance came and one of them was conveyed by the ambulance. We proceed to exchange particulars and was advised to lodge a police report.

I wish to state that my vehicle have an in-car camera and was already handed to the Traffic Police Officer.

I also like to state that my vehicle suffered serious damage on the front and the rear of the vehicle. After the accident I had suffered pain on my back and will be going to see a doctor as I have previous back injury.
