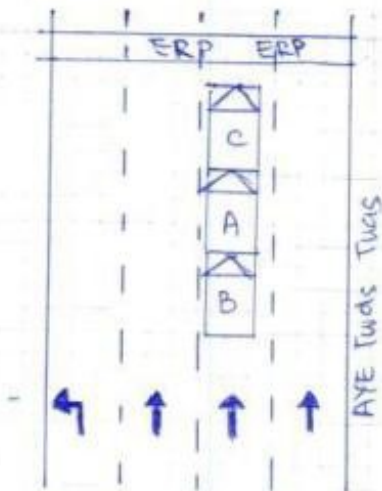

Upon the impact, my vehicle surged forward and collided onto the rear portion of vehicle C. After the accident, I alighted and realised that I was involved in a chain collision accident of 3 vehicles.
