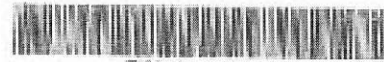

Brief Details.

On 18/10/2019 at about 0230hrs, I was driving my vehicle SKN2408R along ECP towards the city. I had been driving on the first lane. I was feeling fatigued at that time and I believe that I might have dozed off. During which, I had lost control of my vehicle and it collided into the center divider before swerving left and my vehicle was over-turned.

After the incident, I got out of my car and contacted the police. A few officers came to the scene and interviewed. I had sustained several scratches on my knuckles and knees. My vehicle was then towed away and I was advised to lodge a police report. The officers then provided a case card.

I had also given the officers the SD card for my in car OCTV. I recall that a portion of the center divider had been damaged however, I was unable to recall if anything else had been damaged. I have yet to see a doctor however I do not feel pain anywhere.
