**CONTINUATION OF REPORT**

**Brief Details.**

On the 11/10/2019 at about 2040hrs, I was riding my motorcycle bearing registration plate number of VCQ3937 along Upper Pickering Street and was at the entrance/exit of Park Royal Hotel. I was travelling along the first lane nearest to the entrance/exit and there was a taxi bearing registration plate number of SH9134X travelling on the second lane on my left.

The taxi suddenly turned right from the second lane and the taxi's front right bumper collided onto the center of my motorcycle. I fell down and there were no injuries on me at that point of time. I stood up and moved to the side of the road. The taxi driver came to make a check on me and we exchanged particulars. The taxi driver is one Ng Guwan Swee, S0087421C. The taxi's whole front bumper had broke off and my motorcycle's box had scratches, left cover was damaged, gear had jammed and the stand was twisted.

The Police and ambulance came subsequently and the ambulance offered to send me to Singapore General Hospital but as I was not feeling any pain at that point of time I refused. The police told me the report number A/20191011/0139 and asked to lodge a traffic accident report as soon as possible.

On the same day at about 2230hrs, I felt that there was a sharp pain in my left knee. I made a check and discovered that it was swollen. I went to Intemedical 24hrs clinic and was given 3 days MC from 11/10/2019 to 13/10/2019. The MC number is 0000030213. The doctor told me to go back if the pain got worse to do an X-ray.

I am lodging this report as advised by the Police.
