Brief Details.

On 21/10/2019 at about 1340hrs, while I was driving my Malaysian registered vehicle bearing vehicle number JRY8369 along the second lane of Sengkang East Way, I had stopped my vehicle at the junction of Sengkang East Way and Anchorvale Road as the traffic light was red.

Later at about 1345hrs, as the traffic light turned green, I moved off. While my vehicle was entering the said cross junction, out of sudden I saw a blue coloured Taxi bearing vehicle registered number SHA4049J which came out from Anchorvale Road and appeared in front of vehicle. As it was sudden, I was unable to stop in time. As a result, there was a collision between the front portion of my vehicle and right portion of the said Taxi. Upon the collision, I came out of my vehicle and approached the Taxi driver. The Taxi driver apologies to me and admitted that he had beat the red light. Subsequently, ambulance and Traffic police arrived at scene. I was conveyed to Sengkang General Hospital and received 03 days of MC. I had sustained pain on my chest and neck due to the collision. I also wish to state that the front portion of my vehicle was badly damage due to the collision.
