a) **Case IAFP-IB-20191021 - Mechanical Inspection of Motorbus, NCK9059 (TP/IP/32037/2019)**

A1 (NCK9059) was driving off from bus bay located at Woodlands Checkpoint. When he was driving off, a deceased (pedestrian) ran to catch the bus when the deceased tried to step on the front door of the bus while the bus was in motion. The deceased lose balance and fell. As result of the fell, the deceased went underneath the bus and ran over by the front left tyre of the said bus.

b) **Case IAFP-IB-20191021 - Mechanical Inspection of Motorcycle, VAL1344 (TP/IP/33001/2019)**

B1 (VAL1344) was riding his motorcycle along Bartley Road East towards Bartley Road when he veered to the right hit onto the centre divider and skidded for unknown reason. The Deceased was conveyed to TTSH by ambulance. On the same day, B1 succumbed to his injuries and was pronounced dead at TTSH.
