 - (ii) for complying with requirements under any regulations, laws or court orders.



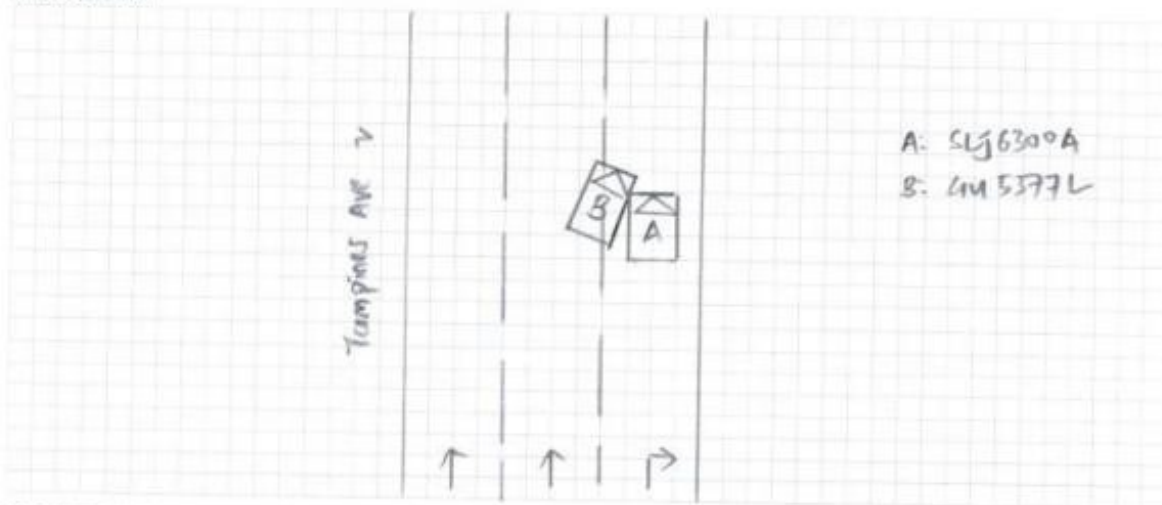


Accident Sketch Plan
