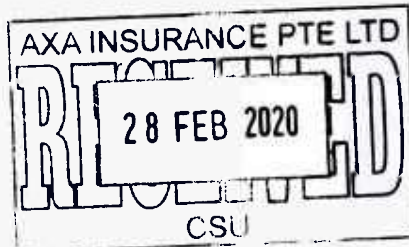

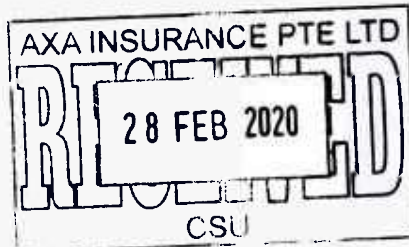

We refer to the above matter.

We have reviewed the matter and based on all the available information on hand, we are of the view that we do not have a good defense towards the claim submitted by the owner of GBJ6467X. Under Motor Accident Guide, vehicle reversing in/out or moving in/out should exercise greater caution. Our driver should confirm traffic clear before reversing. Therefore, we are of the view that liability is not in our driver's favour and we shall proceed to negotiate for an amicable settlement of the third party claim at best to avoid further litigation, which would escalate to even more cost.
