CONTINUATION OF REPORT

Brief Details.

On 29/10/2019 at about 7am, I was driving my car (SGG1628M) along SLE, after Mandai Road. I was driving alone. I noticed that there was a heavy traffic jam. As I drive, the car in front of my car (SLV4125P) suddenly stopped. My car then had a collision with the car in front of me. I then got off from the car and noticed that there was another car (SLV3830T) at the front involved in the collision as well.

I observed the following damages on my car: front bumper went out of alignment, front-right headlight was damaged, driver side door cannot be opened. I also noticed that the car (SLV4125P) had damages such as a dented hind bumper and a cracked front-right headlight. As for the car (SLV3830T) at the front, I noticed that it had a dented hind bumper.

Subsequently, I exchanged contact details with the other two drivers. I then felt unwell and went to seek outpatient treatment at Khoo Teck Puat Hospital and was given 4 days MC from 29/Oct/2019 to 01/Nov/2019. I wished to state that I felt a bit of giddiness and some slight pain at my neck after the accident.

To my knowledge, the other two drivers looked physically fine after the accident. Also, to my knowledge, no government property was damaged. No foreign vehicle was involved. No pedestrian or cyclist was involved. No one was conveyed by ambulance.
