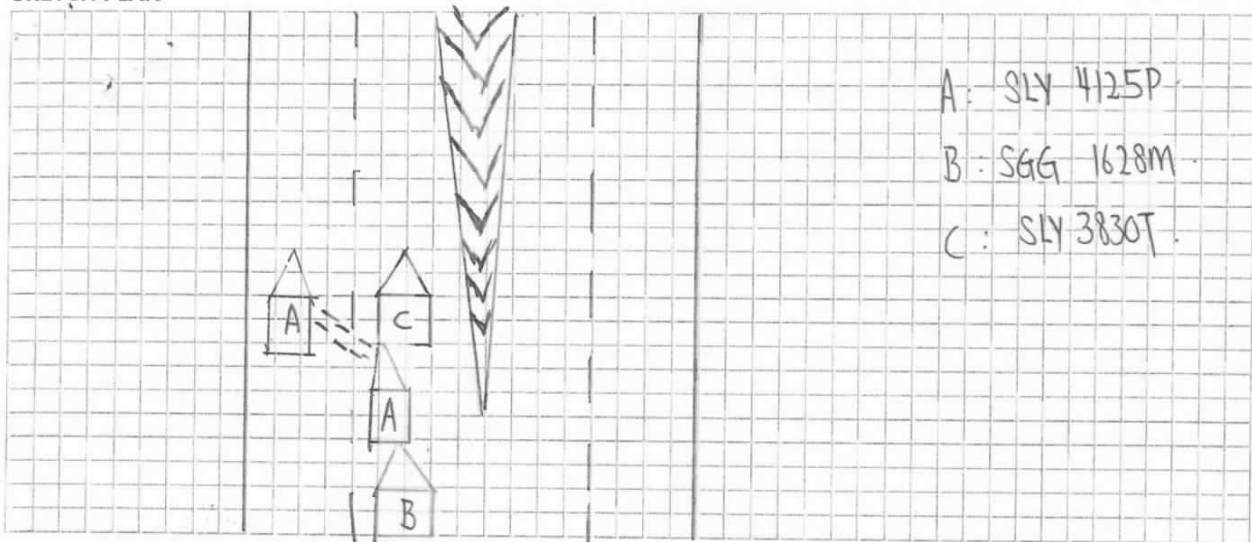

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

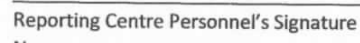
On 29.10.2019 at about 6.57am . I was travelling ^{along} BKE Towards KJE .
