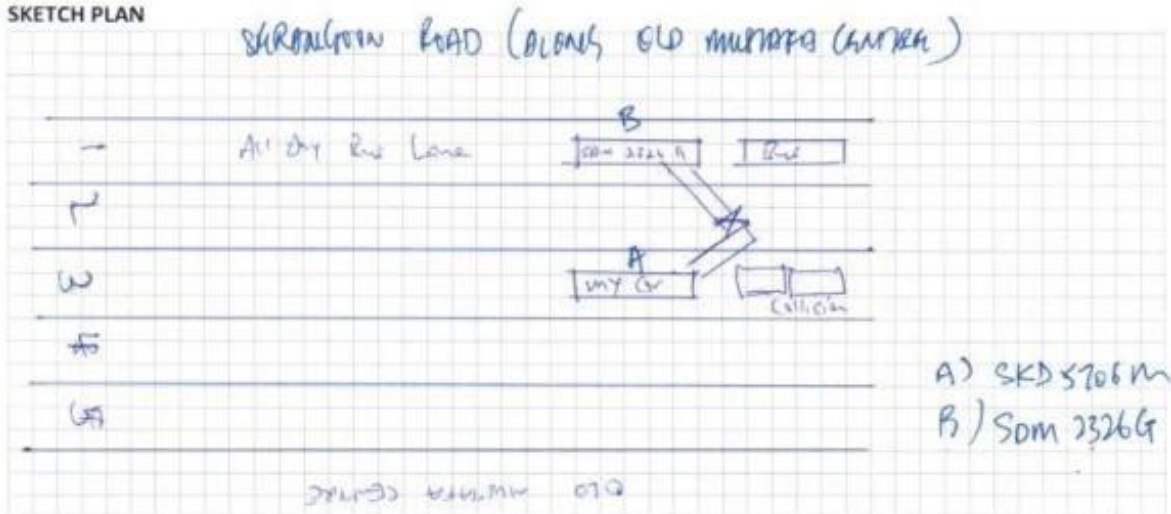

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I, Shabul Hameed, was driving my car (SKD 5706 M) along Skraghon Road (along old Murray Garden), at about 2010 hours on Fri 25 Oct 2019. I was in the third lane (out of 4 lanes). There was a collision between 2 cars in front of me, so I signalled my left indicator to move out to the 2nd lane, on my left. There was another vehicle, SOM 2326 G, driven by Mr. Kumeri (HP 9655 0156). Her car was in the first lane, the bus lane. She indicated her right signal to come out to the 2nd lane.

Both cars came out to the 2nd lane at about the same time and we collided - side to side - with each other. There was no physical injury to anyone.

My car had minor scratches to the left front side. Mr. Kumeri's car had scratches to the right side of the driver door.
