

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Accident Vehicles: XE 3444Y (Client) & GBC 628A

Date of Accident: 07/10/2019

Time of Accident: At about 6.55am

Location: Along Tuas Crescent towards Tuas Avenue 2

BRIEF FACTS OF ACCIDENT CASE

On 07/10/2019 at about 0655Hours, I was driving Company Lorry Reg No: XE 3444Y on the extreme right lane of this 2 lane traffic.

As I was approaching the traffic light junction, I slowed down. Suddenly another Vehicle Reg No: GBC 628A overtook my lorry from the left lane onto the right lane in which my lorry was slowing down.

Vehicle Reg No: GBC 628A after overtaking my lorry suddenly stopped abruptly, giving me no time at all to stop safely.

Due to the dangerous act by driver of GBC 628A switching lanes and stopping abruptly; I had no other choice but to collide onto the rear of GBC 628A.

No one was injured in this road traffic accident.

Due to the impact, as shown in the photographs taken after the road traffic accident, my lorry front windscreen hit GBC 628A canopy top right rear frame and broken; front left headlamp and front left signal light broken and the front lorry bumper damaged.

Photograph evidences proved that my lorry front left vehicle body was damaged because the driver of GBC 628A suddenly switched from left lane to right lane where I was driving my lorry XE 3444Y.
