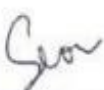

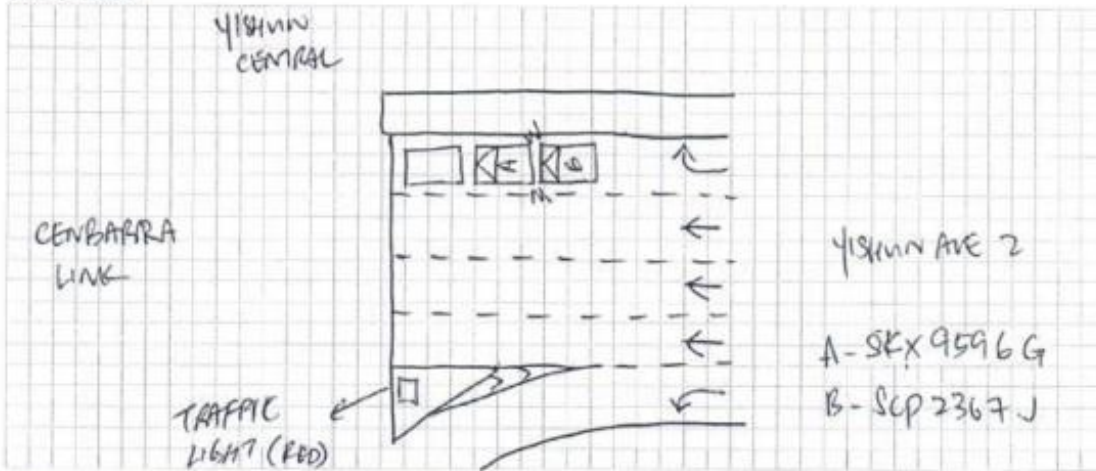

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I WAS TRAVELLING YISHUN AVE 2 TOWARD CEMBARRA LINK ON THE EXTREME RIGHT LANE OF A 4 LANE ROAD. SOMEWHERE JUNCTION YISHUN CENTRAL, VEHICLE IN FRONT OF ME SLOWED DOWN AND STOPPED DUE TO THE TRAFFIC LIGHT (RED). AS SUCH, I ALSO APPLIED BRAKE AND MANAGE TO STOPPED COMPLETELY. AFTER A FEW SECONDS, I FELT AN IMPACT FROM THE REAR PORTION OF MY VEHICLE. AFTER THE ACCIDENT, I ALIGHTED AND REALISE THAT VEHICLE (B) DROVE FROM THE REAR AND COLLIDED INTO THE REAR PORTION OF MY VEHICLE.
