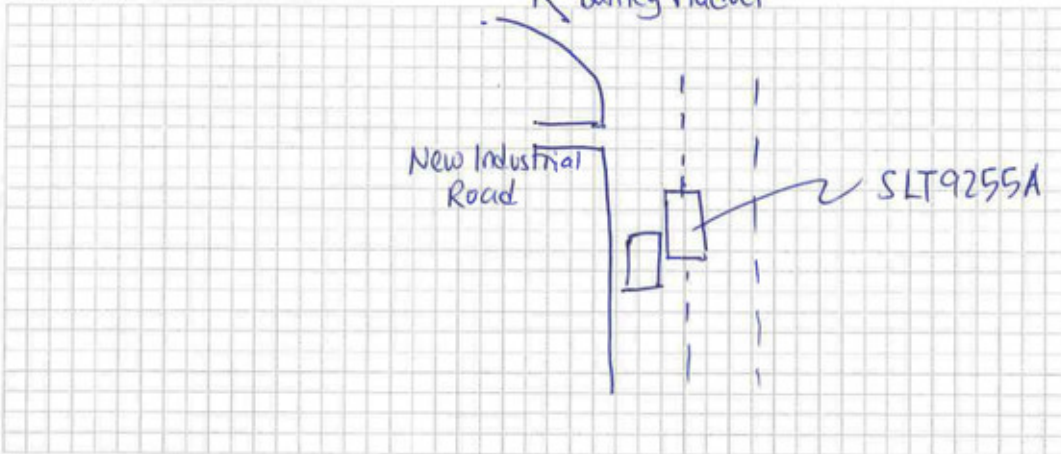

I was driving from Kovan to Bedok along Upper Paya Lebar Road towards Barley Road East when I was nearing the Bartley Viaduct. I was travelling at normal speed when the left lane opened up. I glanced at my rear view mirror and noticed STP863Z a distance away and proceeded to filter to the left. Halfway into the left lane, STP863Z sped up and grazed past my left, scraping and damaged the left side of the car. My left view mirror was also knocked out of position. I stopped my car, got out and took photos and exchanged particulars with the other driver.
