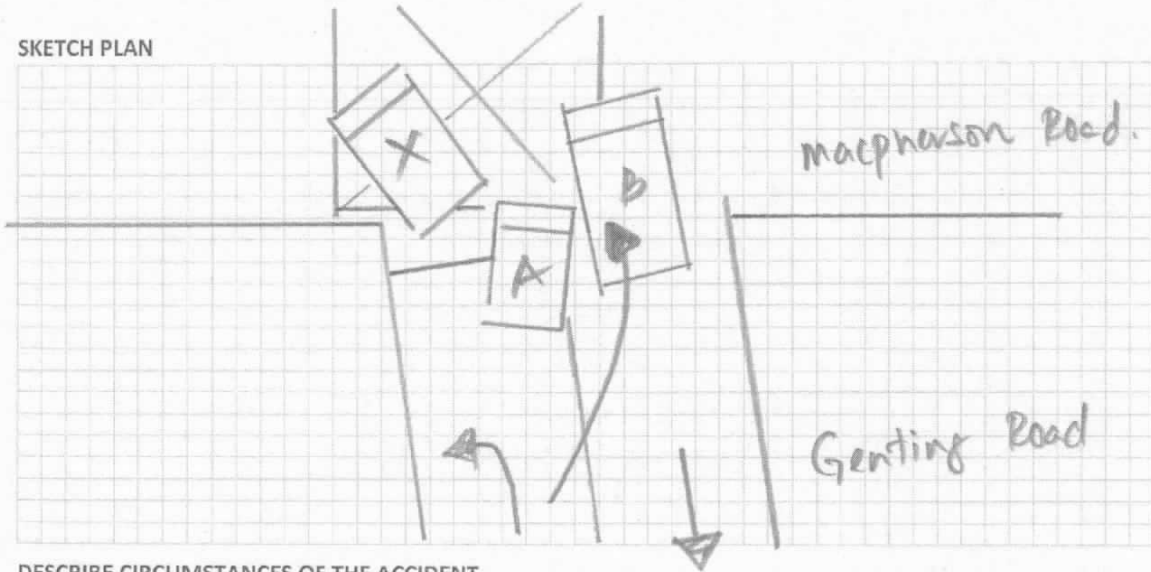

ON 29/10/2019 @ 1150HRS, I WAS DRIVING MY TAXI (SHD 1189 S) – TRAVELLING ALONG GENTING ROAD TOWARDS MACPHERSON ROAD, WITH A PASSENGER ONBOARD.

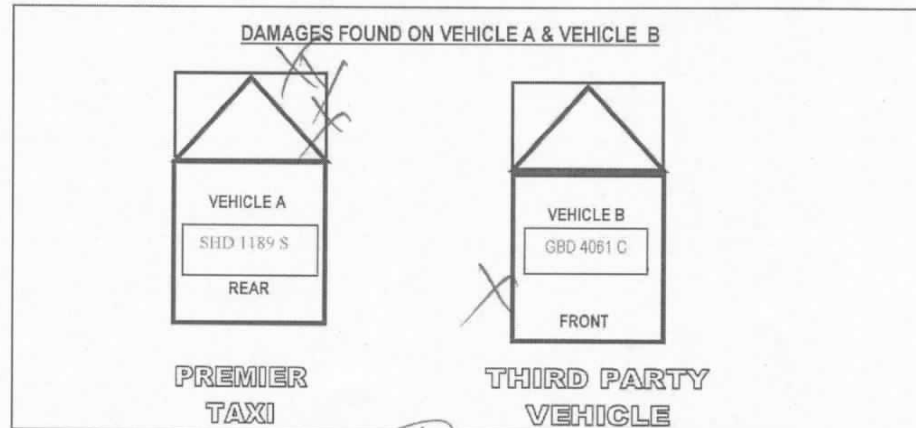
I STOPPED MY TAXI – GIVING WAY TO ONCOMING VEHICLES FROM THE RIGHT (MACPHERSON ROAD). WHILE I WAS ABOUT TO MOVE OFF AHEAD INTO THE YELLOW BOX, SUDDENLY I FELT AN IMPACT FROM MY RIGHT.

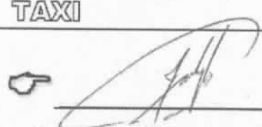
WHEN INSPECTED, I DISCOVERED THAT VEHICLE B (GBD 4061 C – LORRY) WHICH WAS APPROACHING FROM THE BACK – HAD OVERTAKE MY TAXI ON MY RIGHT ABRUPTLY (AGAINST THE FLOW OF TRAFFIC) & COLLIDED ONTO THE RIGHT FRONT OF MY TAXI WHILE HE WAS TURNING LEFT INTO MACPHERSON ROAD.

DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE FRONT RIGHT & THE WHOLE FRONT BUMPER OF MY TAXI RIPPED OFF. VEHICLE B HAD DAMAGES ON THE LEFT PORTION.
