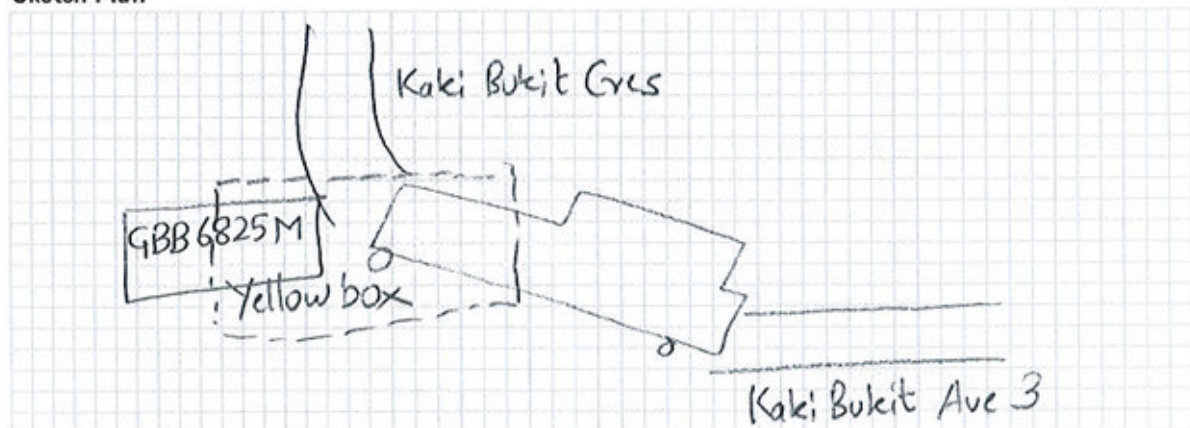

Describe Circumstances of the Accident


I WAS DRIVING ALONG KAKI BUKIT AVE 3 WITH MY DAUGHTER IN THE BACK SEAT (AGE 13 YRS). I HAD TO MAKE A RIGHT TURN TO JOIN KAKI BUKIT CRES. THE YELLOW BOX HAD BEEN LEFT EMPTY BY THE TRAFFIC AND I WAS ABLE TO ~~MAK~~ INITIATE THE RIGHT TURN. HOWEVER, AS I INITIATED THE TURN SLOWLY A SPEEDING WHITE LORRY HIT ME HEAD ON AT AN ANGLE. FORTUNATELY NO ONE WAS INJURED BUT BOTH VEHICLES SUFFERED DAMAGE TO THE FRONT. I HAD NO VISION OF ONCOMING TRAFFIC AS ~~HAS~~ MY VISION WAS BLOCKED BY THE TRAFFIC BEHIND THE YELLOW BOX.
