

On the 31/10/2019, i received a call from James claiming to be Amy's husband from a number 87879884. He requested to go to his workshop for the repairs, but it was only to repair back the bumper which i find unacceptable, and he was no willing to change a new bumper for me, and refusing to give me the number plate of the vehicle which hit into me. I googled the number provided thereafter, and realised it was a contact number for Light House Singapore Pte Ltd located in No. 1, #03-01 Kaki Bukit Ave 3, KB-1, Singapore 416087. I went to the address of Light House Singapore, and i saw an Audi bearing the number plate SLT3973A which i suspect is the vehicle which hit into my Vehicle, as James was loitering around it and taking photos of it.
