Brief Details.

On 20/10/2019 at 9.45am, I was driving my company's lorry YW8964B when I was involved in a minor accident. At that time, I was travelling at Upper Changi Road North and enter the road to New Changi Prison Complex construction site. I then decided to park at the road side to change my pass before entering. I then alighted from my lorry to change my pass. While I was waiting to change my pass about 4 minutes later, suddenly another lorry driver came to me and said that my lorry had hit onto his lorry GBH6468D. I then went out and saw that the said driver's lorry had hit onto my lorry's rear side. I then told him that I had park the lorry prior to his arrival.
