#straightroad Moving straight & Moving straight SMC723C SGD3922R WSVC19002192 Accident_Description While merging into PIE from UBI Avenue 1 the car no SGD3922R stopped suddenly and by the time my car SMC723C braked it slightly bumped into SGD3922R from the rear. Me Tilve Sachin Sudhakar & the Driver of SGD3922R Mr Yeo came out and inspected the damage and we found a small scratch on the bumper of SGD3922R. After initial discussion about exchanging telephone number and other particulars Mr Yeo said its OK and he will not pursue the matter and we left the only after taking one picture of each others number plates. Later in the night Mr Yeo called again saying he wants to file the insurance claim and sent me picture of some damages and took all my particulars. I Tilve Sachin Sudhakar told Mr Yeo that if he wanted to pursue the claim it would have been better if we took pictures at the same time for more clarity and in line with the procedure mentioned by insurance companies. The only picture me or Mr Yeo had taken at the scene is that of our cars number plates. Since I had seen the scratch on the bumper at the scene I have included it in above report. I am not aware about any other damages to the car since there was no inspection done on the scene after Mr Yeo saying he has decided to let go and we can start driving also there was no other visible damage after the slight bump.


