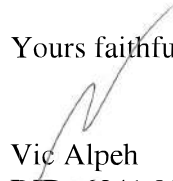
We have received a claim from Body Repairer/Workshop acting on behalf of the owner of SDL 9000E against your motor insurance policy.

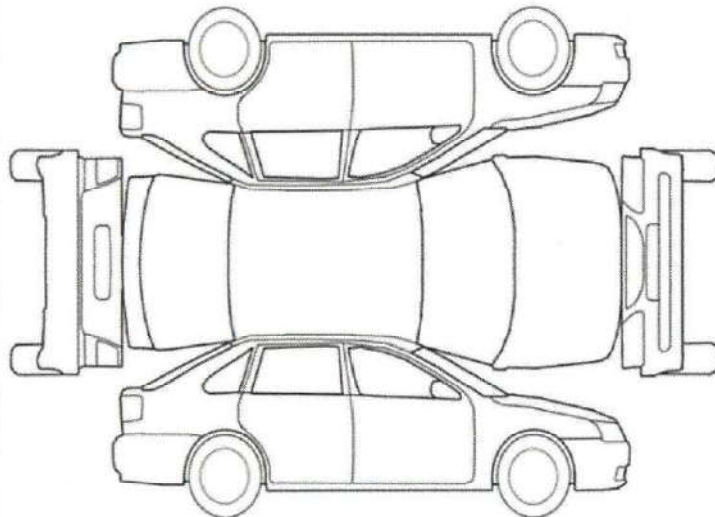

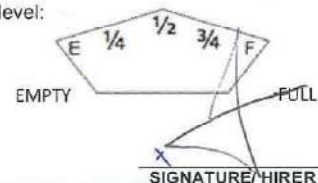
