



Brief Details.

On 13/11/2019, I opened up my letterbox and there was a letter addressed to me and it was from Traffic Police. When I read the letter further, it states that there was a case of traffic accident involving my vehicle, SLV3528S along East Coast Road. The letter also states that the accident happened on 1/11/2019 at about 2.30pm.

On 09/11/2019 at about 1-1.30pm, I parked my car at the parallel carpark lots located at East Coast Road, near to Holy Family Church. During that time, I was with my daughter. After parking the car, I made a check and everything was fine and I headed out for lunch. On the same day at about 2.15-2.25pm, I went back to the same carpark lot to retrieve my car. When I was there, there was another car (unknown registration number) parked in front of me. There was also another car which was parked on the right side of the road. I would like to state that when I wanted to drive out my car, there were little space for me to manoeuvre around as such I drove slowly out of the lot to ensure everything was ok.

After driving out, my daughter then informed me that she heard a small "thud" coming from her side where she was seated. Not thinking much about it, I drove back home. When I was back home, I realised that there were slight scratches present on the rear left panel of the car. No one was injured during the incident. I am therefore lodging this report as per requested.
