

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

DUE TO TRAFFIC ACCIDENT. AT BRADDELL ROAD THERE WAS A JAM. I WAS MERGING INTO THE SLIP ROAD AND NOTICED INDICATED RIGHT SIGNAL. CAR B TRIED TO SQUEEZE IN DESPITE BEING BEHIND ME. I SOUNDED HORN TO INDICATE SHE WAS GETTING TOO CLOSE BUT SHE CONTINUED TO SQUEEZE AND HIT MY RIGHT MIRROR WITH HER LEFT MIRROR. SHE WAVED A "SORRY" AND I CONTINUED MERGING AS I DID NOT REALISE SHE SCRATCHED AROUND MY RIGHT PASSENGER DOOR. (VIDEO 14:51:39)

SO SHORTLY AFTER, YOU CAN SEE IN VIDEO, SHE CUT ACROSS THE SLIP ROAD LINES IMPATIENTLY.


