
WITHOUT PREJUDICE

We refer to the above matter.

Please be informed that our Insured driver confirmed to us that he was already travelling straight and the third party had suddenly turn into his lane and collision ensued. We append below his statement for your easy reference.

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was travelling straight on the extreme left lane of Sin Ming Road (In front of Bik 22) with a tow pump behind my truck.
Vehicle B on my right suddenly cut into my lane, I applied my brake immediately however the collision still could not be avoided.

Insured driver's scene photos (as attached and appended below) shows that the Third party had cut into Insured's lane and there is no (third vehicle -oil pump lorry) behind our Insured tow truck.



Based on all documents at hand and the photos provided by our Insured driver, we opine that liability is down against Third party for turning into our Insured driver's path without proper lookout and care.

As such, we opine that liability is down against your client and we have our principal's instruction to reject the claim and we are unable to look into your client's claim.

We will close file accordingly.

Dear Khanchna

With regards to case above. We do not have video footage in the car.

My client was traveling along Sin Ming Road, when he noticed tow truck Nos : YJ9044R was completed stationary with a truck in tow and a third vehicle, oil pump lorry behind which was refueling the towed truck. Taking note that the truck in tow was having its fuel topped up by this third lorry behind it, my client made a reasonable judgement that it would take sometime before the tow truck would be able to move.

Thus traveling at a very low speed my client signalled appropriately and made to turn left in front of the tow truck, however with no prior indication, the tow truck suddenly moved forward and collided into the side of my client vehicle.

We would like to bring to attention the third vehicle that was refueling the vehicle in tow as evidence to support our statement. Please refer to the attached photos.

As this third refueling vehicle, which is a crucial element of this accident, has evidently been left out of the other party's statement, we would appreciate if our case can be re-evaluated.


